

## Rules and Regulations for Special Cars

Dear exhibitor:

The Organizers welcome you to INA PAACE Automechanika Mexico 2019, the most important event of the automotive parts industry. We thank you for your collaboration and hope that your participation is a successful experience.

Understanding the value that each unit represents for their owners and, in order to assure the best possible conditions for their participation in this event, the Organizers present the following rules to be applied in general for all the exhibitors of special cars:

For purpose of these rules, all vehicles considered as “special” are those in the segments of tuning, antique and sports that will be exhibited in common pavilions and areas of INA PAACE Automechanika Mexico 2019.

We kindly request all special car owners to respect the guidelines and space placement of units assigned by the Organizers.

Civil Protection commands that vehicles must contain the minimum quantity of fuel needed to do placement maneuvers on site, without exceeding the maximum tank reserve.

For the same reason, during the show, it is not permitted to start the engines under any circumstances.

In any case, it is not allowed to carry, distribute or hand out products outside the vehicle, including distribution of flyers, pamphlets, etc. The only vehicles that are allowed to show publicity on the body or interiors will be the units of exhibitors that pay for the corresponding sponsorship to the Organizers.

Each owner is responsible for keeping his/her form in order to further remove his/her vehicle. In case of loss or damage, the Organizer is not liable, and will not obtain any type of authorization to remove the unit.

Without any exception, during the entire event, it is necessary that a person is present with the car keys, in case there is the need of maneuver the vehicle. Understanding this, during the event schedule, the Organizer is not liable for any damages or loss of the vehicle.

Once a location is assigned, all vehicles must be in the exhibition for the entire event. They should also have a technical data sheet and should not show any sign limiting the approaching of visitors. No vehicles are allowed to be removed before the closing of the show.

Since Centro Citibanamex does not have space in the parking lot for vehicles before their entrance, and in order to avoid interference with other moving activities of the show, the owners must commit to strictly respect the following entry and removal schedules for the units:

<b>Tuning</b>	Tuesday July 9th 2019 16:00 to 22:00 hrs.	Friday July 12th 2019 20:30 to 23:00 hrs.

In the case of not complying with these entry and removal schedules of units, the Organizer is not responsible for the vehicles.

The Organizer has the right to take action in order to guarantee the fulfillment of these rules, according to its judgment and to do anything necessary to promote the development of the event.
